

# 4.0 Comments and Coordination

### 4.1 Agency Coordination

KDOT will serve as the lead state agency for the project. FHWA will serve as the lead Federal agency. The Cities of Lenexa, Olathe, and De Soto; Johnson County, Kansas; and the Kansas Turnpike Authority (KTA) are also serving as planning partners during the study process. The environmental review, consultation, and other actions as required by Federal law for this project will be carried out by KDOT and FHWA. The full list of identified agencies invited to coordinate is listed in the Project Coordination Plan in **Appendix I**.

### 4.1.1 Initial Coordination Packet

KDOT, in cooperation with FHWA, prepared an initial coordination packet for distribution to officials and agencies at the initiation of the EA. This packet included a letter inviting the agency to coordinate on the project, a project description detailing the project and a study area map. **Appendix I** contains copies of the invitation letters sent to participating agencies, which were included in the initial coordination packet sent October 11, 2023. **Table 4-1** shows the invited Participating Agencies for the project and the date of response to the invitation. Coordination with Native American Tribes is detailed in **Section 4.3**.

# 4.2 Stakeholder Engagement

#### 4.2.1 Overview

The goal of stakeholder engagement for the K-10 Capacity Improvements Project was to inform the public on the project and provide regular updates, receive feedback, and



collect and review comments about concerns regarding the improvements proposed for K-10. To accomplish the stakeholder engagement goals of the project, the project team performed the following tasks:

- Created and implemented a Community Engagement Plan (Appendix I);
- Developed and implemented a project website;
- Organized and conducted Advisory Group meetings;
- Provided engagement opportunities and places to comment via a project email and comment submission form on the project's website (https://k10.ksdot.gov/);
- Held three rounds of Virtual Public Meetings with opportunities for in-person public open house meetings at Initial Alternatives and Preferred Alternative milestones;
- Sent out regular electronic project newsletters;
- Gave community presentations to organizations in Olathe, Lenexa and De Soto and nearby communities; and
- Conducted surveys and focus groups to understand how people see the future of K-10 and how they would use alternatives if they were implemented.

**Figure 4-1** shows the public outreach events schedule for the EA.




Figure 4-1: Public Outreach Events Schedule

### 4.2.2 Public Meetings

As part of the ongoing NEPA process, three opportunities for the public to view project progress and to provide input on the project were provided. Public meeting 1 was held virtually and available for 30 days for participants to review and provide comments. Public meetings 1, 2, and 3 (to be held in the fall of 2024) were held in-person as well as having a virtual component for those who could not attend. All participants attending the meetings were asked to sign in through a Public Involvement Management Application (PIMA) system established for the project. Each meeting had a specific focus, which is described in the following sections. All meetings and open houses shared project information and it was posted to the project website so that participants could review during their preferred timeframe. All those that attended and signed into the in-person meetings or the Virtual Public Meetings, also signed up for the project



mailing list to receive newsletters and updates about the project. As of May 10, 2024, there are 1,753 people on the project mailing list.

### 4.2.2.1 Public Meeting #1

The first public meeting was held virtually from Wednesday, December 6, 2023 to Friday, January 5, 2024. KDOT hosted a virtual public information open house for the K-10 Capacity Improvements Project. The purpose of the meeting was to present the project overview and existing conditions, as well as gather public input on the draft Purpose and Need. The virtual public meeting was available on the project website (<a href="https://K10.ksdot.gov/">https://K10.ksdot.gov/</a>) for a 30-day period to allow participants to review the information and provide comments at their convenience.

Responses showed this project is of great interest to the community as 459 people signed into the meeting and provided 463 comments. Several participants provided multiple comments that are individually counted. At the conclusion of the public meeting comment period, the database had amassed 1,001 stakeholders signed up to receive project updates. Stakeholders range from the Kansas City metro to Lawrence.

### 4.2.2.2 Public Meeting #2

The second public meeting took place over two dates; Tuesday April 16, 2024 at De Soto High School and Thursday April 18, 2024 at the Kansas State University Olathe Campus. Both meetings were scheduled for 5-7 p.m. The purpose of this round of open houses was to share important project updates including proposed interchange solutions and locations, recommended alternatives being considered, information on the noise study process, and upcoming project activities.

There were 69 attendees at the April 16<sup>th</sup> open house, and 106 attendees at the April 18<sup>th</sup> open house. A virtual option for this round of information launched on April 19, 2024 through May 19, 2024 and 134 people have reviewed the information. Comments were able to be left until May 19, 2024. In total, this public meeting received 36 comments.

#### 4.2.2.3 Public Meeting #3

This meeting will be held in fall of 2024. This section will be updated prior to the approval of the Final EA and FONSI.

### 4.2.3 Advisory Group

An Advisory Group was created at the beginning of the EA process and consisted of 28 business, civic, and religious leaders in the Johnson and Douglas Counties that represent the community. The goal of the Advisory Group was for the project team to gain insight and feedback on the project. The Advisory Group established in the Spring 2023 was comprised of the members shown in **Table 4-3**.

Each of the four Advisory Group meetings were held virtually. The first meeting was held in May 2023 and overviewed the project and its purpose and goals. ### 4.2.4 Community Surveys and Focus Groups

ETC Institute was contracted to conduct two community surveys. For each, a survey packet containing a cover letter, a copy of the survey, and a postage-paid return envelope was sent to a random sample of households in eastern Johnson and Miami Counties. Residents who received the survey were also given the option of completing it online or via a follow up phone call. The first survey was administered in November 2023 and completed by 1,051 residents. The second survey was administered in March 2024 and completed by 1,068 residents. Both surveys exceeded the goal of 800 participant responses. Complete reports with the survey results can be found in **Appendix K**.



### 4.2.5 Community Presentations

The project team presented to community organizations throughout the Overland Park area and region as requested. The purpose of the presentations was to provide information on the K-10 improvement options and answer questions. Members of the public and community, civic or business organizations could request a community presentation by email, submitting a comment on the project website, or by filling out the 'Request a Presentation' form at the bottom of the project website or through a member of the project team.
