The Osage Nation Historic Preservation Office has received the NEPA scoping document for the proposed KDOT, 10-46 KA-6549-01, K-10 Corridor Improvements from west of the interchange at Evening Star Road to I-35, Johnson County, Kansas. **The Osage Nation requests a copy of the Draft Environmental Assessment (EA) for review and comment when it is completed.** 

In accordance with the National Historic Preservation Act, (NHPA) [54 U.S.C. § 300101 et seq.] 1966, undertakings subject to the review process are referred to in 54 U.S.C. § 302706 (a), which clarifies that historic properties may have religious and cultural significance to Indian tribes. The Osage Nation has a vital interest in protecting its historic and ancestral cultural resources. This project will directly impact ancestral Osage cultural resources that have significant cultural value to our Osage community today. This area is of great concern to the Osage Nation as it falls within our former reservation lands and is in close proximity to several known cultural resources. The Osage Nation anticipates reviewing and commenting on the completed Draft Environmental Assessment for the proposed KDOT, 10 -46 KA-6549-01, K-10 Corridor Improvements from west of the interchange at Evening Star Road to I-35, Johnson County, Kansas.

When Section 106 consultation is required for the proposed KDOT, 10-46 KA-6549-01, K-10 Corridor Improvements from west of the interchange at Evening Star Road to I-35, Johnson County, Kansas, the Osage Nation requests that the Osage Nation Historic



Preservation Office be consulted and provided with the cultural resources survey report for the referenced project. The Osage Nation requires that cultural resource survey personnel and reports follow the Secretary of Interior's standards and guidelines. Please provide detailed topographic maps depicting the locations of the shovel tests and test units excavated during the survey along with a table indicating their depth, soils, the amount and type of material found, and reason for termination.
